# **Second Annual Review of Master Plan Shows Significant Progress for Louisiana Universities**

**BATON ROUGE, La** – Commissioner of Higher Education Jim Purcell announced today that Louisiana has achieved notable progress towards meeting the three goals outlined in the 2011 Master Plan for Higher Education. The second-annual review of the Master Plan—which is designed to be implemented over a 15-year time period— outlines 19 objectives, 71 activities and 97 performance measures to achieve the following goals:

- 1. Increase the educational attainment of the State's adult population to the Southern Regional Education Board (SREB) States' average by 2025;
- 2. Invest strategically in university research; and
- 3. Achieve greater efficiency and accountability in the postsecondary education system

#### Results pertaining to Goal #1 include:

- The total number of students requiring remediation in Math and/or English decreased by 2.5% and 5.3%, respectively, from baseline levels.
- The number of high school students enrolled in postsecondary education courses increased 11.5% from the baseline year.
- The number of students completing a postsecondary education credential increased 13.2% over the baseline year.

#### Results pertaining to Goal #2 include:

 Campus research expenditures showed significant growth over baseline reporting.

#### Results pertaining to Goal #3 include:

- Continued implementation of the performance-based funding formula.
- Implementation of an annual academic program review process.
- Movement towards a more balanced enrollment mix between two-year and four-year institutions.
- Continued development of a remedial education pilot program.
- Most institutions met their targeted GRAD Act goals, and were subsequently awarded increased tuition authority and retained their performance funding.

"We are very pleased with the Master Plan progress during this second annual review," said Commissioner Purcell. "This shows that our institutions are indeed making the necessary changes to adapt to this difficult economic environment. It is important to note that the areas where universities experienced slight declines, are directly aligned with the significant reductions to higher education's state general fund appropriations; a challenge that must be addressed."

#### Regents Will Not Pursue Litigation Regarding Act 360

During today's meeting, the board met in executive session to discuss the legal implications of Act 360 of the 2013 Regular Session. The Board expressed many concerns about the deviation from the constitutionally prescribed process and the policy implications of Act 360. "We believe it was our duty to defend that process during the legislative session as the only means to develop a unified, comprehensive and impartial capital outlay budget for all of higher education," said Regents Chair, W. Clinton Rasberry. "However, the legislature and the governor, to whom we are constitutionally responsible for providing our advice and recommendation, took a different view. We accept that. We will continue, as the coordinating board to advocate for all of higher education."

# Regents Launches Operation Recall to Recruit Out-of-State Graduates

The Board of Regents, in partnership with the state's Workforce Cabinet Agencies, will soon be reaching out to thousands of Louisiana graduates who are now living in other states with hopes of recruiting them back for employment through a new initiative called Operation Recall. As an immediate solution to addressing workforce shortages, emphasis will be placed on graduates who have left the state with a credential in a high demand area. "We will be targeting those who are graduates in areas such as Computer Science and Engineering," said Commissioner Purcell. "These are critical areas of our workforce where human capital is desperately needed."

Specifically, Operation Recall will:

- ✓ Provide Workforce Cabinet agencies and universities with an updated database of former students' most recent contact information for targeted communication.
- ✓ Create a geographical representation of where graduates currently live and/or work to build strategy around recruiting efforts.
- ✓ Contact alumni about career opportunities in Louisiana that would be of interest to them.

Regents has engaged the services of a third-party global technology vendor to identify a variety of income, lifestyle, and workforce-related information about our graduates. The vendor is also tasked with locating the most recent contact information. To date, information for over 300,000 alumni from Louisiana colleges and universities has been identified consisting of graduates from 1998 to 2013.

Data shows that that 85 percent of our graduates are still residing in Louisiana, with heavy populations in metropolitan areas, along with cities where colleges and universities are located. The remaining graduates who are living outside the state are primarily living in Texas, Mississippi, and California.

"With the influx of businesses in our state, graduates that are residing in other states need to be informed of the good opportunities that are available," said Regents Chairman, W. Clinton Rasberry, Jr. "Let's do what it takes to bring them back home to help build our state's economy."

Enhanced data and information collected through Operation Recall will be used by participating agencies for the planning of Louisiana job fairs in other states, the notification of employment opportunities, announcement of new businesses, along with the recruitment for graduate school opportunities and alumni organizations.
