Regents Extends Developmental Education Co-Requisite Delivery Pilot

Today, the Board of Regents approved the continuation of the Developmental Education Co-Requisite Delivery Pilot through 2014-2015. The Developmental Education Co-Requisite Delivery Pilot began in Fall 2012 to explore alternative approaches to developmental instruction by studying the concurrent delivery of college-level and developmental instruction for students who are nearly ready for college-level English and Mathematics courses at two-year colleges and regional universities.

In April 2010, Regents approved the minimum statewide admission standards policy which states that beginning Fall 2014, students needing developmental work would not be admitted to a public university under regular admission standards.

Currently, 15 institutions are participating in the pilot with more than 700 students enrolled. To qualify students must: (1) be within two points of the AcAf 2.18 policy's minimum requirements for placement; (2) enroll in a 3-credit college-level English or Math course, plus a 1-3 hour non-degree-credit co-requisite developmental/support offering; and (3) take a post-test at the end of the course. In addition, the campus must strongly advise the student to complete the subsequent college-level Math or English course in the next term of enrollment. Participating campuses must report student progress to Regents each semester.

"We believe that this study will assist us in determining if modifications should be made to the policies and practices pertaining to admissions standards," said Commissioner Purcell.

In continuing the pilot, implementation of the Fall 2014 non-developmental admission requirement would be postponed for students who are participating in the developmental pilot program at regional universities. Additionally, the provisions of the minimum requirements for college entry-level Mathematics and English (as outlined in the AcAf 2.18 policy) would be suspended for students participating in the pilot.

"The continuation of this pilot would allow Louisiana postsecondary institutions to further evaluate instructional options and develop effective approaches for students who are at or near the established placement breakpoint," said Associate Commissioner of Academic Affairs, Dr. Karen Denby. "It would allow regional universities to offer admission to qualified students while research is being collected, and would enhance the national discussion on developmental education."

Using the pilot data reported through the 2013-14 academic year, staff will make a recommendation regarding current policy and college-level placement by the 2015-2016 recruitment period.
