Regents Approve Electronic Learning For Deployed Students

The Board of Regents today approved a plan that makes it possible for college students activated for military duty to continue their studies electronically, where possible, while stationed overseas or in the United States. The program is the first of its kind in the nation.

Under the program, called e-SGR (electronic-learning Support for Guard and Reserve), Louisiana public college and university students called to active duty while enrolled in classes will, where duties and location allow, be able to continue their studies via Louisiana's "Electronic Campus," as well as a host of other e-learning (continued on page 2)

Regents Approve Formula Revision For Teacher Preparation Accountability System

The Board of Regents approved a revision in the formula for calculating the Teacher Preparation Performance Score under the Teacher Preparation Accountability System.

For 2002-2003 the score will be calculated using a weighted formula that takes into account the institution's regular and alternate certification completer rate (with extra points for completers who meet definitions for identified shortage areas), the PRAXIS examination passage rate, and the score on a standardized survey measuring completer satisfaction.

Previously, the Teacher Preparation Performance Score was based solely on the PRAXIS examination passage rate.

The Electronic Campus is a catalog of more than 700 courses, including 13 complete degree programs, available from public colleges and universities all across the state, conducted via the internet. General education courses will be the immediate target of e-SGR, making use of the new Board of Regents e-Matrix (an on-line course articulation matrix) for general education courses. In cases where the electronic equivalents of courses needed by activated students are available through the system (whether from the campus where the student was enrolled or elsewhere), arrangements can be made for students to earn some of their needed credit while activated, thereby reducing the delay in degree completion that might otherwise result from extended activation.

The e-SGR program was approved in honor of the late Carol Coltharp, an employee of the Louisiana Community and Technical College System and a former Regents Assistant Commissioner. Coltharp was the driving force behind the Regents' 1991 deployment policy for students activated during Operations Desert Shield and Desert Storm.

Louisiana is the first state to embark on such an endeavor, but other states are expected to use Louisiana's e-SGR as a model for similar programs.
