


Regents Recap

LA Shows Growth in Graduation Rates

Baton Rouge, LA – Today, the Board of Regents received a status update on several high-priority topics in higher education. An area where notable progress has been made is graduation rates at Louisiana public 4-year institutions. Since 2004, Louisiana's graduation rates have increased by nearly 6 percentage points. Dr. Tremblay, Deputy Commissioner for Planning, Research, and Academic Affairs stated that overall increases in graduation rates could be attributed in part to the new admission standards that were implemented in 2005. He added that the Board of Regents recognizes that the admission standards should align with the mission of each institution to ensure appropriate access. Thus, the effectiveness of admission standards will be revisited in the upcoming months.
