# **Regents Recap**

#### **Regents Remains Focused on Efficiencies** Announces Results of Academic Program Review

**Baton Rouge, LA** –In an effort to enhance program quality, ensure that our universities are good stewards of resources, and to make certain that programs are aligned to state and regional needs, staff of the Louisiana Board of Regents conducted its 2014-2015 Academic Program Review, and the Board approved its recommendations today.

According to Regents, there must be evidence of local student and prospective employer demand as well as an expectation that the new program would become self-sustaining after a reasonable implementation period. The statewide program review repeats that analysis of existing programs to assess whether they should be maintained in the curriculum inventory, i.e., whether program continuation is justified based on costs, productivity, and relevance to student or campus progression. The statewide review is conducted every other year to provide time for actions triggered by the current review to have an impact on program productivity.

As part of the process, Regents staff identified programs for which a response is required, triggered primarily by the number of awards conferred over the last three years.

Institutions are encouraged to take the opportunity to organize or restructure based on a self-evaluation of their entire academic program inventory. "The review process provides an opportunity for a thorough examination of an institution's program offerings in light of its own fiscal realities," said Commissioner of Higher Education, Dr. Joseph C. Rallo.

This year, 177 programs were included in the review. For each program, the campus prepared a proposition and justification to either continue, consolidate, or terminate the program. Staff considered campus requests, in light of the statewide inventory and both duplication and access issues from both a statewide and regional perspective, depending on the program and its relationship to other majors. Consideration was also give to current and projected trends in enrollment and productivity, and to the institution's explanation of and interventions to improve the current status. Relative to the 177 Academic Programs, the Board approved the following:

-Continuation of 112 programs (with enrollment updates at staff request); -Termination of 56 programs;

-Consolidation of nine programs, with the cancellation and revision of programs in the Curriculum Inventory, as warranted.

"The statewide Academic Program Review should be repeated in 2016-17, after the 2015-16 completer reports are finalized," said Dr. Karen Denby, Associate Commissioner for Academic Affairs. **Regents Members** Roy O. #### **Board of Regents Awards 258 Support Fund Grants to Campus Personnel**

Today, the Board of Regents awarded 258 Support Fund Grants to faculty/staff at thirty-nine campuses across the state. This includes:

- Four Endowed Chair for Eminent Scholar matches to attract and retain faculty at the highest levels of research and teaching;
- Seventy-eight Enhancement Grants to establish more competitive environments for research and/or teaching at flagship, research, regional, special-purpose, and two-year campuses;
- The establishment of seventy-three Endowed Professorships at campuses across all levels to recruit and retain faculty of quality;
- Matching of twenty-three Endowed Undergraduate Scholarships at campuses with bachelor's and associate's degree programs to attract and retain first-generation college students;
- Thirty-two Research Competitiveness grants to emerging faculty for the purpose of strengthening research infrastructure and leveraging federal dollars;
- Nine Industrial grants to faculty working with industrial partners on economic development initiatives;
- Seventeen awards which encourage faculty in the arts and humanities to complete significant scholarly and creative works;
- Nineteen awards to support thirty-three master's and doctoral fellows across STEM disciplines;
- In collaboration with SREB, three awards for eight doctoral fellowships which promote faculty diversity.

Eleven of the thirteen BoRSF subprograms are competitive, resulting in 76% of the dollars being awarded on a merit basis. Also during FY 2014-15 matching funds were provided for continuation of five major Federal Matching programs which have competed successfully at the national level; these multi-year programs, receiving \$12,469,000 in federal dollars, provide rates of return which range from \$1 to \$9.90 for each matched Support Fund dollar.

"This is a very exciting day for the Board of Regents," said Regents member and Sponsored Programs Committee Chair, Joseph Wiley. "Awarding funds to the hard-working faculty and staff in support of research and teaching is critically important."
