Nova Southeastern University Fort Lauderdale, Florida

BACKGROUND

Nova Southeastern University (Nova) is not incorporated in the State of Louisiana and first registered with the Board of Regents in 1978. The institution is a private comprehensive university headquartered in Fort Lauderdale, Florida and accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACS/CoC).

ACADEMIC PROGRAM

Although Nova offers over 100 programs online, currently there are Louisiana residents enrolled in nine online programs (two doctorates and seven masters). The programs include areas related to business administration, counseling, education, education law, general psychology, and speech-language pathology.

FACULTY AND STUDENTS

Nova employs 32 faculty to support its online programs available to Louisiana residents, 14 on a full-time basis. Twenty-eight of the 32 faculty are trained at the doctoral level.

FACILITIES

Since Nova operates programs online with administrative and academic support in Ft. Lauderdale, there are no out-of-state physical facilities in Louisiana. Students will complete clinical experiences at various locations within the State.

STAFF RECOMMENDATION

Given the credentials of its faculty, the institution's and academic programs' accreditation, and the general oversight by the home campus, the senior staff recommends that the Board of Regents approve the license renewal for Nova Southeastern University, located in Fort Lauderdale, Florida.

Executive Summary

The State Authorization Reciprocity Agreement (SARA) is a national initiative which seeks to establish comparable national standards for the interstate offering of postsecondary distance-education courses and programs. SARA membership makes it easier for students to take online courses offered by institutions based in another state by reducing the cost and administrative burden on institutions seeking authorization in various states. SARA is a voluntary agreement among regional compacts (SREB, NEBHE, MHEC, and WICHE) and member states. Each member state approves their in-state institutions and renews their membership annually. Approved SARA member institutions may offer distance education programs in other SARA member states without additional authorization.

Act 13 of the 2014 Regular Session of the Louisiana Legislature authorized the Louisiana Board of Regents to seek SARA membership on behalf of the State of Louisiana. In October 2014, Louisiana's application for SARA membership was approved by the Southern Regional Education Board (SREB) and the National Council for State Authorization Reciprocity Agreements (NC-SARA), effective December 1, 2014. Since then, 26 Louisiana institutions have joined SARA. Institutions must renew with NC-SARA annually in order to maintain their membership.

Five institutions (Louisiana State University Alexandria, Nations University, Southern University A&M College, University of Louisiana at Lafayette and University of Louisiana at Monroe) have submitted SARA renewal applications. Regents' staff have reviewed the renewal applications and determined that they meet all requirements for continuing their membership in SARA.

Senior staff recommends that the Planning, Research & Performance Committee approve the Renewal Applications for Institutional Participation in SARA for Louisiana State University Alexandria, Nations University, Southern University and A&M College, University of Louisiana at Lafayette and University of Louisiana at Monroe, and authorize staff to submit the approved applications to NC-SARA for final approval of SARA membership renewal.

Minutes
Board of Regents' Proprietary Schools Advisory Commission
March 12, 2019

The Louisiana Board of Regents' Proprietary Schools Advisory Commission met on Tuesday, March 12, 2019, at 10:03 a.m., in Room 1-190 of the Claiborne Building, Baton Rouge. Chair Fontenot called the meeting to order. Following an introduction and word of welcome from Chair Fontenot to Dr. Karen Denby, Interim Deputy Commissioner, and to new Commission member Carmen Million, an appointee of the State Association of Better Business Bureaus, and the administering of the Oath of Office to Ms. Million by Assistant Attorney General Patricia Wilton, the roll was called.

The first item of business was the approval of the minutes from its meeting of January 8, 2019.

On motion of Ms. Potter, seconded by Mr. Lalonde, the Proprietary Schools Advisory Commission unanimously adopted the minutes of the January 8, 2019 Proprietary Schools Advisory Commission meeting.

The next agenda item considered by the Commission was an initial license application from CDL Mentors, LLC, located in Lake Charles, Louisiana, and represented by the school's owner, Mr. Herman Marigny III. Ms. Marabella reviewed the materials for the Commission members, informing them that the institution was proposing to offer two programs of study to prepare for a commercial drivers license: CDL Training (Class A) – a four week, 160.0 clock hour program; and CDL Training (Class B) – a two week, 140.0 clock hour program. CDL Mentors, LLC, had met all the legal and administrative requirements to be approved for an initial license.

Following further discussion regarding the industrial expansion in Lake Charles and the resulting need for licensed commercial drivers, the types of CDL certifications and endorsements offered to students, the available equipment for training, the estimated compensation for graduates, the school owner's background and work experience, and the recognized nationwide shortage of commercial drivers,

On motion of Ms. Amrhein, seconded by Ms. Potter, the Proprietary Schools Advisory Commission unanimously recommends that the Board of Regents approve an initial operating license for CDL Mentors, LLC, located in Lake Charles, Louisiana.

The next agenda item considered by the Commission was an Associate in Occupational

Studies (AOS) Degree application from Delta College of Arts and Technology, Inc., located in Baton Rouge, Louisiana. Mr. Richard Wilson, School Director, was in attendance to represent the school.

Ms. Marabella reminded the Commission members that the Proprietary Schools Law requires that AOS degrees be offered only by schools that hold recognized accreditation and that the Board of Regents must approve all AOS degree program offerings. Delta College of Arts and Technology, Inc., has been licensed as a Louisiana proprietary school since June 25, 1992 and is accredited by the Council on Occupational Education.

The application for the AOS Degree in Business Management and Ownership (105.5 quarter credit hours/1,486.0 clock hours) is designed for full-time students to be able to complete the program requirements in 16.5 months. Graduates would be prepared to seek employment in a managerial capacity or utilize their business skills as entrepreneurs in the business world. Delta College of Arts and Technology, Inc., had met all the legal and administrative requirements to be approved by the Board of Regents.

Following further discussion regarding the school's plan to transition from a current diploma program to the AOS degree program, the development of the AOS degree program was driven by industry demand and recommendation by the school's advisory board, potential employment possibilities for graduates, and the program's focus on entrepreneurship,

On motion of Ms. Hay, seconded by Ms. Amrhein, the Proprietary Schools Advisory Commission unanimously recommends that the Board of Regents approve the Associate in Occupational Studies Degree in Business Management and Ownership for Delta College of Arts and Technology, Inc., located in Baton Rouge, Louisiana.

The next agenda item considered by the Commission was operating license renewals.

Ms. Marabella informed the Commission members that there were seventeen (17) schools seeking renewal. These schools scheduled for renewal were in complete compliance, having met all the legal and administrative requirements to be re-licensed.

Following further discussion,

On motion of Ms. Potter, seconded by Ms. Hay, the Proprietary Schools Advisory Commission unanimously recommends that the Board of Regents renew the licenses of the following proprietary schools (initial license date in parentheses).

Ms. Marabella informed the Commission that there were four institutions that did not renew their licenses this renewal cycle: Louisiana Healthcare Institute (02/22/16), Rosepine Louisiana Medical Training, LLC (02/22/16), Virginia College--Baton Rouge (05/27/10), and

Virginia College--Shreveport (05/26/11). Staff will follow through to secure the student records from each school for safekeeping.

The next item on the agenda was an update on program approvals. Chair Fontenot reminded the Commission that staff approved these updates administratively and course approvals were being shared for informational purposes only.

The next agenda item discussed by the Commission was the proposed revisions to the current proprietary schools law. It is the goal of the Board of Regents to have these revisions considered during the Spring 2019 legislative session. Ms. Marabella gave an overview of the review process that has been followed to date. Staff will be meeting next week with proprietary school representatives to discuss the proposed changes to the statute.

Ms. Marabella also provided the Commission members an update on the digitalization of the student records from closed proprietary schools.

The next meeting of the Proprietary Schools Advisory Commission is scheduled for Tuesday, May 14, 2019, at 10:00 a.m., in Room 1-190 of the Claiborne Building. There being no further business, the meeting adjourned at 10:47 a.m.
