AGENDA ITEM VII.A.1. Fiscal Year 2020-2021 Update

- Revenue Estimating Conference met on May 11, 2020, to adopt a forecast for FY21 that reduced State General Fund revenue by \$867M, a decrease of 8.6%.
- House Bill 105 (General Appropriations Bill) passed the House Appropriations Committee (HAC) with amendments on May 21, the House Floor with no amendments on May 26 and was sent to Senate Finance Committee.
- The amendments adopted by HAC decreased State General Fund for higher education by a total of \$104M.
 - The reductions totaled \$121.6M.
 - The enhancements totaled \$17.6M
- These reductions and enhancements are illustrated in the chart on the next page.

AGENDA ITEM VII.A.2. CARES Act Support for Higher Education

- Louisiana public institutions allocated \$186.8M
 - \$73.6M for student financial aid
 - \$73.6M for institutions for COVID-19 expenses
 - \$39.5M for institutions serving minorities and low-income students
 - \$0.18M for LSU Health Sciences Center Shreveport
- Governor's Emergency Education Fund \$50.3M
 - Funds are for K-12 and higher education based on a plan that will be determined by the Governor. A maintenance of effort is required.
- HEROES Act
 - On May 15, 2020, the U.S. House of Representatives passed a bill that would provide \$100B for K-12 and Higher Education and \$500B for states governments
 - The funds for education would be to maintain or restore funding to local school districts and postsecondary institutions.
 - The funds for state governments can be used for COVID-29 related expenses, to replace foregone revenues not projected on January 31, 2020, or to respond to negative economic impacts of COVID-19.




