### **COVID-19** Partnerships





- The Baton Rouge land mass is hosting COVID-19 testing for all employees, faculty, staff and students. Currently, we are partnering
  with the Mayor's office for free COVID-19 testing, and CareSouth will also provide COVID-19 testing, flu screenings and vaccinations
  throughout the Fall 2020 semester. Our Student Health Center is also prepared to conduct COVID-19 testing, along with routine
  medical services for our students. We believe that these initiatives will be important as we strive to promote access, ensure safety
  and provide a greater level of comfort for our campus community.
- The SUBR team is working closely with our medical resource partner, Ochsner Healthcare System, to ensure consistent building sanitization, the availability of PPEs and medical resources, and immediate access to medical care throughout the Fall 2020 semester and beyond.
